
The Aussie market had another choppy day that finished negatively. The US market gave a negative lead while Chinese economic update did not help the sentiment. China weak growth to persist despite flagging around 5% growth while US is starting to wobble. Tech optimism has started to price in too much as Apply sales in China falls over. Growth is fading while inflation is getting sticky. Central Banks are positioned to ignore any pickup in inflation as political pressure remains high. We are starting to see weak EM economies see second inflation wave while DM economies continue to pile into debt on rate cut hopes. US mega techs are pricing in decades of AI driven growth where any disappointments are hard to absorb. The latest iphone sales in China has come up over 20% short and that will shake a few trees with stretched multiples. Gold continues to hit new all time high for the second day in a row. Market keeps climbing the wall of greed with rising macro risks. Gold is showing that risk management is back in play. It may be different this time!

AFR on intraday moves on stocks...Seven of the index's 11 sectors flashed red, with consumer stocks leading losses as supermarket giant Coles and jeweller retailer Lovisa traded ex-dividend. Health stocks had a good day after the government allowed insurance premiums to rise from April. The announcement sent Medibank 1.6% higher to \$3.75 and NIB up 3.4% to \$7.85. And Healius was the star performer of the index, up 14.7% to \$1.29, the biggest daily gain since 2020 after the troubled pathology group named Paul Anderson as its new chief executive in charge of a strategic review. Pharmaceutical group Telix rallied 1.2% to \$12 on plans to buy Canadian tech ARTMS in a \$126 million deal. Gold miners outperformed as prices of the precious metal shot up to their highest in three months and in sight of a record high. St Barbara jumped 12.5% to 18¢, Regis Resources 5.5% to \$2.03, and Ramelius Resources 4.3% to \$1.575. Northern Star Resources rose 3% to \$14.13, its highest closing since April last year. In contrast, lithium explorers struggled. Pilbara Minerals was the index's biggest laggard, falling 7% to \$4.1. IGO dropped 5.3% to \$7.73, Sayona 6.7% to 4.2¢ and Liontown 4.1% to \$1.275.

CNBC on China...China set a growth target of "around 5%" for 2024 and announced the issuance of "ultralong" special bonds for major projects, according to a government work report Tuesday. Premier Li Qiang, who delivered the report, also pledged that China would remove restrictions for foreign investment in manufacturing. China set a deficit-to-GDP ratio of 3% for the year, down from a rare upward revision to 3.8% late last year from the original 3%.

The current state of global markets is marked by a bear market cycle, with fluctuations that are causing both positive and negative outcomes for investors. Historically, 75% of retail investors have experienced losses during positive market periods. Investors are now facing market cycles that are unprecedented in their lifetime, making risk management a crucial aspect of investing. The annual inflation rate in Turkey rose to 67.07% in February 2024, accelerating from 64.86% in the previous month and coming more than market estimates of 65.74%. It was the highest reading since November 2022, driven by a solid rise in minimum wage and adjustments in government taxes. Prices increased faster for all subgroups, particularly food & non-alcoholic beverages (71.2% vs 69.71% in January), transport (77.98% vs 77.54%), and housing & utilities (49.07% vs 45.99%). Additionally, inflation went up for furnishings, household equipment, & routine maintenance (62.92% vs 61.10%), hotels, cafes & restaurants (94.78% vs 92.27%), clothing & footwear (43.44% vs 40.62%), and miscellaneous goods & services (61.86% vs 58.95%). Meanwhile, the core inflation quickened to 72.89% in February from 70.48% in the prior period. On a monthly basis, the CPI grew 4.53%, moderating from a 5-month high of 6.70% advance in January.

The Judo Bank Flash Australia Services PMI Business Activity Index rose to 53.1 in February, from 49.1 in the prior month, final readings showed. It marked the first expansion in services activity in five months and the quickest since April 2023, as a renewed rise in new orders led to business activity returning to growth. Improvement in demand conditions rose services activity, suggesting better economic conditions and increased enquiries supported the latest rise in new work. New export business also returned to growth for the first time since September 2023, supported by new client wins and increased interest from clients in Asia. As such, service providers hired more staff at an accelerated pace to cope with new workloads and enabled firms to clear their outstanding business for a twentieth straight month. On the price front, input costs continued to increase, attributed to rising shipping, fuel and labour costs.

The au Jibun Bank Japan Services PMI was revised higher to 52.9 in February 2024 from 52.5 in the flash reading and after January's four-month high of 53.1. It marked the 18th straight month of expansion in the service sector, supported by the steepest rise in new business since last August amid tourism demand and new product launches. However, growth was mainly driven by domestic demand, as foreign demand stagnated. Rises in new business and indications of capacity pressures led to a solid increase in employment that was the most marked for nine months, with backlogs of work rising solidly and to the greatest extent in nine months. On prices, input cost inflation eased to the second-weakest since October 2021, while output cost inflation accelerated to the strongest in six months. Finally, business sentiment weakened to a four-month low. It remained above the series average amid hopes of increases in business investment over the coming year and business expansion plans.


The Caixin China General Service PMI moderated for the 2nd straight month to 52.5 in February 2024 from 52.7 in January. It was the 14th straight month of expansion in services activity but the softest pace since last November amid a subdued increase in overall new work. New order growth was little changed and remained slower than the average seen in 2023. However, export orders rose the most in eight months amid reports of firmer customer demand across external markets. Employment fell for the 1st time in three months, with the rate of job shedding being the quickest seen in over a year due to subdued demand conditions. Meantime, outstanding business dropped for the 1st time since July 2022. On the cost side, input prices rose due to higher raw material and fuel costs.


#### **Global Markets**




