
MARKET COMMENTARY


The Aussie market was hit hard as the economic reality of rising bond yields and the lack of global fund flow support played out. Today was surprisingly a day when global funds weren't pumping miners or banks to hold the market up. Banks peaked back at previous recent all time high and has been pulling back while miners had their wind taken away with China stimulus hopium fading. The local market is stuck between the US election, Middle East war expansion and slowing local economy. The local economy is in recession for the bottom half of the population while the debt fueled asset bubble keeps the top end of town wealthy. The problem with debt fueled asset bubbles is that asset prices are cyclical while debt only goes down when you can pay it. Given the massive increase in cost of living, not many are paying but more and more are adding more debt. US government interest payment has gone above their defense spending. Given their war spending, US debt cycle is in a death loop where defense and interest payment will keep deficits for decades. Pundits are worried about an election to see which path to economic mess we are going to take while the house is already on fire. The mess started a while ago and the unaffordable corporate tax cuts locked in the pain cycle pre pandemic. It may be different this time!

CNBC on US Tech restrictions > Measures aimed at curbing U.S. investments into China in sensitive technologies are in the final stage of review, a U.S. government update showed. Under this set of rules, the Treasury Department will require notification of outbound investments into China in sensitive technologies including artificial intelligence, semiconductors, microelectronics and quantum computing that can be employed for developing military capabilities. The final rules will likely be released within the "next week or so," according to Reuters. The proposals are part of the Joe Biden administration's efforts to restrict the flow of U.S. capital, technology and expertise into China that could support its military modernization and undermine U.S. national security.

CNBC on China Tech restrictions > China has unveiled a set of export control regulations for so-called dual-use items, which refer to goods or technologies that can be used for civilian as well as military purposes, ahead of President Xi Jinping's trip to Russia. The regulations come amid intensified U.S. sanctions targeting Chinese companies which the U.S. deems have been supplying dual-use goods, such as drones, to aid Russia's war effort in Ukraine. The measures, which will take effect from Dec. 1, aim to "safeguard national security and interests, promote global cooperation on non-proliferation, strengthen and standardize export controls on dual-use items," the State Council said Saturday, according to CNBC's translation of the statement in Chinese. Xi will be attending the BRICS summit in the Russian city of Kazan from Tuesday to Thursday, according to China's foreign ministry.

The People's Bank of China slashed key lending rates to new lows at the October fixing, intensifying efforts to support a weakening economy. The one-year loan prime rate (LPR), the benchmark for most corporate and household loans, was cut by 25bps to 3.1%, and the five-year rate, a reference for property mortgages, was reduced by the same margin to 3.6%. The lending rates were last cut in July. Monday's decision followed Governor Pan Gongsheng's indication last week that the LPR would be lowered by 20 to 25bps. He also suggested that the reserve requirement ratio (RRR) for commercial banks could be reduced further in Q4. Recently, the PBoC and the Ministry of Housing introduced a range of policies to ease the financial burden on property owners and regain public confidence. In September, China's central bank began its most aggressive stimulus measures since the pandemic, including measures to support the ailing property sector and boost consumption.

Producer prices in Germany dropped 1.4% year-on-year in September 2024, slipping further from a 0.8% decrease in the previous two months. This marks the 15th consecutive period of producer deflation, driven by a sharp decline in energy prices (-6.6%), with costs falling for mineral oil products (-14.4%), light heating oil (-27.8%), fuels (-16.1%), natural gas (-10.4%), and electricity (-9.5%). Excluding energy, producer prices rose by 1.2%. Meanwhile, the biggest price increases were seen in capital goods (2%), driven by higher costs for machinery (2.1%) and motor vehicles and parts (1.5%). Prices also rose for consumer goods (1.5%), durable goods (0.9%), and intermediate goods (0.5%). On a monthly basis, producer prices fell by 0.5%, the first decline since February, coming more than forecasts of a 0.2% fall and following a 0.2% rise in August.

Producer inflation in South Korea slowed further to 1 percent year-on-year in September 2024, from 1.6 percent in a month earlier. It was the lowest figure since November 2023 mostly due to a fall in cost of manufacturing products (-0.4 percent vs 1.1 percent in August). Meanwhlie, factory gate price rose at the same pace for service (2.1 percent vs 2.1 percent), while picked up for electric power, water, and gas (3.8 percent vs 3.7 percent) and agricultural, forestry, and marine products (+3.8 percent vs -1.1 percent). On a monthly basis, producer prices fell by 0.2 percent, the same pace as previous month.


Public sector net borrowing, excluding public sector banks, in the UK rose to £16.6 billion in September 2024, up from £14.5 billion in the same month of the previous year but below market expectations of £17.5 billion. Total public sector spending increased by £5.9 billion to £105.9 billion, driven by higher debt interest and increased spending on public services, partially offset by reduced benefit expenditures. Meanwhile, receipts grew by £3.8 billion to £89.3 billion, largely due to higher central government tax revenues. For the financial year ending in September 2024, borrowing reached £79.6 billion, £1.2 billion more than the amount borrowed in the same six months last year and £6.7 billion higher than the £73.0 billion forecast by the OBR for this period. This marks the third-highest year-to-September borrowing since monthly records began in January 1993.


Global Markets


