


The Aussie market rolled over today to start the first week of December on the negative. Macro news continues to show rising inflationary pressure and fading growth outlook. The US Fed is keeping their rate cut trend due to ever-growing interest cost for US budget while bond market is keeping yield higher. South Korea and France are in political mess while Germany is leading EU into another decade of no growth. China keeps delivering solid economic updates while preparing for trade war while US keep adding more swamp to the new administration. Tax cuts need funding and that means tariffs are going higher while inflation is going to follow and weigh on growth. The US political cycle is looking very much like a third world country with friends are family getting posts around the world. Global funds are holding US and Australian markets by targeting a small group of stocks in a sector. The currency move has made the Australian investment a loss maker. They are defending for now but how long will that last? It may be different this time!

CNBC on Indian Rate Cycle > India's central bank expectedly kept the benchmark interest rate unchanged at 6.50% on Friday as it struggles to contain rising inflation without hurting growth in Asia's third-largest economy. The decision came in line with economists' expectation in a Reuters poll, as India's consumer prices inflation surged to a 14-month high of 6.21% in October, significantly higher than the central bank's target of 4% and also above its tolerance ceiling of 6%. Reserve Bank of India Governor Shaktikanta Das said the central bank had revised India's GDP growth outlook for fiscal year 2025 down to 6.6% — RBI had forecast 7.2% growth in October — adding that the slowdown in the domestic economy had "bottomed out" in the September quarter.

CNBC on OPEC+ > The OPEC+ oil producers' alliance has postponed plans to unwind several formal and voluntary crude production cuts into 2026 amid a lukewarm outlook for global demand, according to delegate sources and internal documents. The sources could only speak anonymously because of the sensitivity of talks. Under its formal output strategy, the broader OPEC+ coalition is now restricting its combined production to 39.725 million barrels per day (bpd) until Dec. 31, 2026, after previously only applying this quota throughout 2025. Eight OPEC+ members will now extend their 2.2 million-barrel-per day voluntary production decline into the first quarter and will begin hiking production incrementally between April and September 2026. Several OPEC+ members will also be postponing the unwinding of a second 1.7-million-barrels-per-day cut until the end of next year. This latter production decline was previously only set to last through 2025.

Historically, 75% of retail investors have experienced losses during positive market periods. US employers announced 57,727 job cuts in November 2024, slightly higher than 55,597 in October and 45,510 a year earlier. The Automotive sector announced the most job cuts (11,506, the highest monthly total since April). "The Automotive industry is currently experiencing significant challenges, including potential tariffs affecting U.S. automakers with overseas factories, intensifying competition from Chinese electric vehicle (EV) manufacturers, and shifts in government subsidies for EVs. Additionally, leadership changes, such as the recent resignation of Stellantis CEO Carlos Tavares, are contributing to the sector's volatility", Andrew Challenger, Senior Vice President of Challenger, Gray & Christmas, Inc. For the year, companies have announced 722,566 job cuts, up 5.2% from 686,860 announced through November of last year. It is the fourth-highest November total since 2008.

Canada posted a trade deficit of CAD 0.92 billion in October of 2024, narrowing from the CAD 1.26 billion gap in the previous month but wider than market expectations of a CAD 0.8 billion deficit. Despite the improvement, it marked the eighth consecutive monthly deficit. Imports rose by 0.5% to CAD 65.1 billion, led by metal ores (+46.1% to CAD 3.2 billion) and energy products (+6.2% to CAD 7.9 billion), offsetting declines in consumer goods (-1.6% to CAD 11.5 billion) and chemicals (-2.3% to CAD 4.2 billion). Exports increased by 1.1% to CAD 64.2 billion, driven by metal and non-metallic mineral products (+10.6% to CAD 8.6 billion), including unwrought gold (+20.9%), and pharmaceutical goods (+36.8% to CAD 4.1 billion). Exports to the US fell 2.8%, narrowing the surplus with the US from CAD 7.9 billion to CAD 6.2 billion, while exports to other countries surged 13.1%, reducing the non-US trade deficit from CAD 9.2 billion to CAD 7.1 billion.


The trade deficit in the US narrowed to \$73.8 billion in October 2024 from an upwardly revised \$83.8 billion gap in September and compared to forecasts of a \$75 billion shortfall. Exports declined 1.6% to \$265.7 billion due to lower sales of industrial supplies and materials, consumer goods, passenger cars, trucks, buses, and computer accessories. On the other hand, exports rose for travel, transport, charges for the use of intellectual property, telecommunications, computer, and information services, and maintenance and repair services. Meanwhile, imports contracted 4% to \$339.6 billion, with purchases falling for computers, semiconductors, automotive vehicles, parts, and engines, crude oil, and pharmaceutical preparations.

US initial jobless claims rose to 224,000 for the week ending November 30, from 213,000 in the previous week, above market expectations of 215,000 and marking the highest reading in six weeks. Despite this rise, the results still support the view that the US labor market remains at historically strong levels despite the aggressive tightening cycle by the Federal Reserve in the last quarters, adding leeway for the central bank to slow the pace of monetary loosening should inflation remain stubbornly high. Meanwhile, the four-week moving average, which reduces week-to-week volatility rose by 750 to 218,250. On the other hand, the non-seasonally adjusted claim count fell by 34,967 to 210,166, with notable decline in California (-9,777), Texas (-6,383), Florida (-2,601) and Georgia (-2,510). Moreover, outstanding claims fell by 25,000 to 1,871,000.

Nominal wages in Japan rose by 2.6% year-on-year in October 2024, marking the slowest growth since May, in line with market expectations. In contrast, inflation-adjusted real wages—an important measure of consumers' purchasing power—remained flat compared to October 2023. This was an improvement from the 0.4% decline in September and a 0.8% drop in August. The stability in real wages bolsters expectations for an interest rate hike by the Bank of Japan this month, although market sentiment remains split on whether the next increase will come in December or January. BOJ Governor Kazuo Ueda indicated last week that a rate hike is imminent, as the economy is progressing according to forecasts. However, BOJ board member Toyoaki Nakamura suggested on Thursday that he may oppose a rate hike in December. Additionally, overtime pay—a key indicator of corporate health—rebounded in October, growing by 1.4% after a 0.9% decline in the previous month.


