
MARKET COMMENTARY

The Aussie market started positively and rolled over as global investors started to take profit ahead of the US Fed interest rate update. The local federal budget update flagged the good times are over and deficits are coming for the next decade. We always knew the budget and the economy was in a structural mess and it needed reform, but we got changes on the edges with no big reform. The trade cycle is starting to roll over and that means a weak outlook for growth and currency. The currency is already testing multi-year lows and the budget outlook left it open to break below. RBA changes raised the potential for a rate cut but the data is not even on the planet. The Canadian inflation came is below 2% since April and that is mainly due to BOC moving hard to fight inflation and take the price of economic slowdown and lower property prices. RBA is not willing to do that and that means extended recession for the bottom half of the population. The US retail sales data beat expectations and proved that US Fed has no real reason to cut tonight despite the implied probability is over 90%. The bond and currency markets are not buying the US spin. The US Fed is starting to look like BOJ. BOJ was ponzi for three decades because the rest of the world was not a ponzi. The US can't load up on debt and do ponzi and expect it to last. It may be different this time!

CNBC on US/China geopolitics > Congress is set to vote in the coming days on legislation restricting U.S. investments in China as part of a bill to fund government operations through mid-March, lawmakers said late on Tuesday. In October, the Treasury finalized rules effective Jan. 2 that will limit U.S. investments in artificial intelligence and other technology sectors in China that could threaten U.S. national security. The bill expands on those restrictions and includes other provisions aimed at concerns about China, including a requirement to study national security risks posed by Chinese-made consumer routers and modems and mandate reviews of Chinese real estate purchases near additional national security sensitive sites. The Chinese Embassy in Washington did not immediately comment.

CNBC on Nissan/Honda Merger > Nissan Motor shares surged Wednesday following a media report that the struggling Japanese automaker is looking to merge with Honda Motor, forming a bigger entity that can compete with larger rivals and invest more in the growing market for electric vehicles. Nissan shares were last trading up 23.7%, while Honda shares slipped 3%. Honda and Nissan are considering operating under a holding company, and will soon sign a memorandum of understanding, according to a report in the Nikkei newspaper. They plan to eventually bring Mitsubishi Motors, in which Nissan is the top shareholder with a 24% stake, under the holding company, according to the report. Speaking to CNBC, Vivek Vaidya, global client leader for mobility at research firm Frost & Sullivan, said the merger was triggered by the financial underperformance of Nissan.

Australian Trading Day Market Report

The annual inflation rate in Canada was at 1.9% in November of 2024, easing from the 2% in the previous month and undershooting market expectations of 2%. The result was in line with the Bank of Canada's baseline scenario that CPI inflation is due to remain close to the 2% threshold for the foreseeable future. Still, the trimmed-mean core rate was unchanged at 2.7% instead of expectations that it would ease to 2.5%, limiting the magnitude of rate cuts that the monetary authority may deliver to aid economic growth. Gasoline prices fell to a lesser extent (-0.5% vs -4% in October) as base effects faded, driving transportation costs to accelerate (1.1% vs 0.2%). In turn, inflation decelerated for shelter (4.6% vs 4.8%) as softer price growth for mortgages offset higher inflation for rent. Inflation also eased for food (2.8% vs 3%) amid slowing inflation in grocery stores. From the previous month, the Canadian CPI was unchanged.

Retail sales in the US increased 0.7% mom in November 2024, following an upwardly revised 0.5% rise in October and above forecasts of 0.5%. The data continued to point to a robust consumer spending during the holiday shopping season. Biggest increases were recorded for sales at motor vehicles and part dealers (2.6%) and non store retailers (1.8%). Increases were also seen for sporting goods, hobby, musical instrument, & book stores (0.9%); building material & garden equipment supplies dealers (0.4%); furniture (0.3%); electronics and appliances (0.3%); and gasoline stations (0.1%). In contrast, sales were flat at health and personal care stores and declined at miscellaneous store retailers (-3.5%); food services and drinking places (-0.4%); food and beverages stores (-0.2%); clothing (-0.2%); and general merchandise stores (-0.1%). Meanwhile, sales excluding food services, auto dealers, building materials stores and gasoline stations, which are used to calculate GDP, increased 0.4%.


Industrial production in the United States fell by 0.1% from the previous month in November of 2024 to extend the 0.4% contraction in October, and contrasting with market expectations of a 0.2% rise. The result was consistent with other surveys that pointed to softness in US manufacturing, unveiling the sector's struggle ahead of potential tariffs by President-elect Trump next year. Manufacturing output, which accounts for nearly 80% of industrial production, edged higher by 0.2% in the period from the revised 0.7% plunge in October. This was offset by a 0.9% drop for mining output and a 1.3% decline for utility output and distribution.

Japan's trade deficit plunged to JPY 117.62 billion in November 2024 from JPY 813.87 in the same month a year earlier, marking the smallest trade gap since July 2023. The latest result was much lower than market consensus of a shortfall of JPY 688.9 billion, as exports rose while imports shrank. Sales increased by 3.8% to JPY 9,152.38 billion, accelerating from a 3.1% rise in October and topping forecasts of a 2.8% growth. Meanwhile, purchases declined by 3.9%, swinging from a the prior 0.4% increase, defying expectations of a 1.0% gain.

The Westpac-Melbourne Institute Leading Economic Index in Australia was up 0.1% month-over-month in November 2024, following a 0.2% rise in the previous month. Meanwhile, the six-month annualized growth rate in the index, which indicates the likely pace of economic activity relative to the trend three to nine months into the future, slightly lifted to 0.32% in November from 0.22 in October. It was the first back-to-back positive reads on the index growth rate in nearly 2-1/2 years, amid optimism that economic output will expand slowly over the next few quarters. Australia's GDP is forecast to rise from 0.8% yoy pace currently to 2.2% by the end of 2025. "We expect the central bank to leave interest rates unchanged at its February meeting, with an easing expected to commence in May," said Matthew Hassan, head of Australian Macro-Forecasting.




