#### **MARKET COMMENTARY**

The Aussie market was hit hard after the US market was bashed on US Fed update. The US Fed has flipped on the rate cut cycle sentiment. They followed through on the 25bps cut as expected but cut outlook to 2 cuts per year going forwards to an upgraded 3%. The US Fed chair was pivoting from weakness worry to inflation worry again. We were sitting on a historically stretched US market being 65% of the global market where the next market was at 5.5%. November saw the biggest inflow into US, and it was mainly into techs. US fund managers were sitting on historical high equity weighting and historically low cash weighting. We could not work out why they were cutting, and the bond and currency markets were not buying the spin. The US Fed had to face reality that they were cutting to pump markets or reducing interest cost on the budget. But both became unaffordable with inflation picking up. NZ has fallen into recession again while BOJ is doing everything it can to ignore data and keep rates on hold to support the carry trade. The long-negotiated US government short term funding deal has been tanked by Murk and Trump. We may be facing a government shut down during Christmas and New Year holidays where government workers are not paid. Prepare for economic management mess over 2025. Imagine if the new government tanks the economy to force US Fed to cut rates into reflation cycle. It may be different this time!

CNBC on US Fed > The Federal Reserve on Wednesday lowered its key interest rate by a quarter percentage point, the third consecutive reduction and one that came with a cautionary tone about additional cuts in coming years. In a move widely anticipated by markets, the Federal Open Market Committee cut its overnight borrowing rate to a target range of 4.25%-4.5%, back to the level where it was in December 2022 when rates were on the move higher. Though there was little intrigue over the decision itself, the main question had been over what the Fed would signal about its future intentions as inflation holds steadily above target and economic growth is fairly solid, conditions that don't normally coincide with policy easing.

CNBC on NZ > New Zealand's economy sank into recession in the third quarter as activity dived far more sharply than expected and output in the prior quarter was slashed, a dire result that cements the case for more aggressive rate cuts. The shock news sent the local dollar to a fresh two-year low of \$0.5614, having already shed 2.2% in the wake of a hawkish easing from the U.S. Federal Reserve. Markets added to wagers the Reserve Bank of New Zealand would slice rates further, having already cut by 125 basis points to 4.25%. Swaps now implied a 70% probability of a 50-basis-point cut in February, and rates were seen declining to 3.0% by the end of 2025. Thursday's data showed gross domestic product dived 1.0% in the September quarter from the prior quarter, dwarfing market forecasts of a 0.2% contraction.

Historically, 75% of retail investors have experienced losses during positive market periods. The annual inflation rate in the Eurozone increased to 2.2% in November 2024 from 2% in October, but below 2.3% in the preliminary estimate. This year-end increase was largely expected due to base effects, as last year's sharp declines in energy prices are no longer factored into annual rates. Prices of energy fell at a much softer pace (-2% vs -4.6% in October, compared to -1.9% in the preliminary estimate) and cost for non-energy industrial goods rose more (0.6% vs 0.5%, compared to 0.7% in the preliminary estimate). On the other hand, inflation eased for services (3.9% vs 4%, matching the preliminary estimate) and food, alcohol and tobacco (2.7% vs 2.9%, also below 2.8% in the first estimate). Compared to the previous month, the CPI fell 0.3%, matching the figures from the advance estimate. Annual core inflation was confirmed at 2.7%, in line with the flash reading.

Building permits in the United States soared by 6.1% to a seasonally adjusted annualized rate of 1.505 million in November of 2024, erasing the 0.4% decline from the previous month and firmly above market expectations that it would have risen to 1.43 million. It was the sharpest increase since February 2023, lifting permits to their highest annualized level since February 2024. Single-family permits rose by 0.1% to an annualized rate of 972 thousand, while permits for building with five or more units soared by 22.1% to 481 thousand. These were enough to offset the 3.7% drop in buildings of two to four units, which totaled a rate of 52 thousand. Permits grew in all regions of the US, including the South (5.7% to 798 thousand), Midwest (10.7% to 217 thousand), the Northeast (11.3% to 158 thousand), and the West (1.8% to 332 thousand).


The Fed announced another 25bps cut to the federal funds rate in December 2024, marking the third consecutive reduction this year and bringing borrowing costs to the 4.25%-4.5% range, in line with expectations. The so-called dot plot indicates that policymakers now anticipate just two rate cuts in 2025, totaling 50 basis points, compared to the full percentage point of reductions projected in the previous quarter. The Fed also revised its GDP growth forecasts upward for 2024 (2.5% vs to 2% in the September projection) and 2025 (2.1% vs 2%), while remaining steady at 2% for 2026. Similarly, PCE inflation projections have been adjusted higher for 2024 (2.4% vs 2.3%), 2025 (2.5% vs 2.1%), and 2026 (2.1% vs 2%). The same trend applies to core PCE inflation, with forecasts raised for 2024 (2.8% vs 2.6%), 2025 (2.5% vs 2.2%), and 2026 (2.2% vs 2%). On the other hand, unemployment is seen lower this year (4.2% vs 4.4%) and in 2025 (4.3% vs 4.4%) while the forecast was kept at 4.3% for 2026.

Consumer inflation expectations in Australia increased to 4.2% in December 2024 from 3.8% in the previous month, marking the highest level since September. This rise followed the Reserve Bank's decision to maintain the cash rate at 4.35% for the ninth consecutive meeting during its final session of 2024. While acknowledging that headline inflation has eased significantly, the board warned that underlying inflation remains too high. In October, the monthly CPI index rose by 2.1% year-on-year, holding steady for the second consecutive month and remaining at its lowest level since July 2021, due to the ongoing impact of the Energy Bill Relief Fund rebate. In Q3, the country's annual inflation stood at 2.8%, the lowest since Q1 2021. However, the trimmed Mean CPI rose 3.5% yoy, surpassing the central bank's 2-3% target.

The Bank of Japan (BoJ) maintained its key short-term interest rate at around 0.25% during its final meeting of the year, keeping it at the highest level since 2008 and meeting market consensus. The vote was split 8-1, with board member Naoki Tamura advocating for a 25bps increase. Thursday's decision came despite the US implementing its third rate cut this year, as the BoJ needed more time to assess certain risks, particularly US economic policies under Donald Trump and next year's wage outlook. The board adhered to its assessment that Japan's economy is on track for a moderate recovery, despite some areas of weakness. Private consumption continued its upward trend, aided by improving corporate profits and business spending. Meanwhile, exports and industrial output remained relatively flat. On inflation, the yoy figures have ranged between 2.0% and 2.5%, driven by higher service prices. Inflation expectations showed a moderate rise, and the underlying CPI is expected to add gradually.


