
MARKET COMMENTARY


The Aussie market was sliding all day and finished the day negatively. It was mainly about the banks and specifically about Commonwealth Bank (CBA). It was hit by a 5% sell off after the result. The worst day since Liberation Day selloff when passive global money was running for cover. Nothing special about the result except there was no growth for a stock trading at multidecade high multiple. That's right...market was shocked that CBA wasn't a growth stock. Most of the banks were hit on the back of that as well. If you remove the hit on the banks, market may have closed flat to slightly positive. Th reporting season volatility has started and there are reality checks being delivered while some fantasy multiples were being protected by fund managers. AGL was another story of defensive growth with little growth at massive multiples and it ran into selling pressure. We are coming off US inflation as expected while core and super core beat expectations. US core inflation has passed 3% while US Fed is targeting 2%. RBA rate cut did not fool the bond market which is basically holding yields mainly flat despite three RBA cuts. Global chip wars are back again. US is taxing China chip sales and China is warning against Nvidia chips. It may be different this time!

CNBC – US on Chips > The Trump administration is still working out the details of its 15% export tax on Nvidia and AMD and could bring deals of this kind to more companies, the White House's Karoline Leavitt said Tuesday. "Right now it stands with these two companies. Perhaps it could expand in the future to other companies," said Leavitt, the White House's spokesperson. "The legality of it, the mechanics of it, is still being ironed out by the Department of Commerce, and I would defer you to them for any further details on how it will actually be implemented," she continued. President Donald Trump confirmed on Monday that he had negotiated a deal with Nvidia in which the U.S. government approves export licenses for the Chinaspecific H20 AI chip in exchange for a 15% cut of revenue. Advanced Micro Devices also got licenses approved in exchange for a proportion of its China sales, the White House confirmed.

CNBC — China on US Chips > China has told companies to refrain from using Nvidia's H20 chips after the chipmaker recently received approval to resume shipping the less-advanced artificial intelligence product, Bloomberg reported, citing sources familiar with the matter. Authorities have recently told companies to avoid using the Nvidia chips, or those from Advanced Micro Devices, for government and national security use cases, according to the news outlet. The report comes after the White House confirmed on Monday that both Nvidia and AMD have agreed to give 15% of all China revenues to the U.S. government. Last month, both companies said they would soon resume China shipments after the administration started requiring export licenses earlier this year. Both Nvidia's H20 chip and AMD's MI380 were created to work around previous AI chip restrictions to China due to national security fears.

The ZEW Indicator of Economic Sentiment for the Euro Area fell by 11 points from the prior month to 25.1 in August 2025, below market estimates of 28.1. In August, about 55.9% of the surveyed analysts expected no changes in economic activity, 34.6% predicted improvement and 9.5% anticipated a deterioration. In the meantime, the indicator of the current economic situation decreased by 7 points to -31.2 and inflation expectations went down by 0.9 points to -6.7.

The US government posted a \$291 billion budget deficit in July 2025, despite a \$21 billion boost in customs duty collections from higher tariffs under President Trump, as spending outpaced revenues. The shortfall was \$47 billion larger than a year earlier, with receipts rising 2% to \$338 billion and outlays jumping 10% to a record \$630 billion for the month. According to the Treasury, fewer business days in July reduced receipts by about \$20 billion; adjusting for this would put the deficit at roughly \$271 billion. Gross customs receipts soared to about \$28 billion from \$8 billion a year earlier due to the higher tariffs. Over the first 10 months of the fiscal year, the deficit reached \$1.629 trillion, up 7% from the same period last year. Receipts climbed 6% to a record \$4.347 trillion, while outlays increased 7% to \$5.975 trillion, also a 10-month record.


The US annual inflation rate remained at 2.7% in July 2025, the same as in June and below forecasts of 2.8%. Price pressures increased for used cars and trucks (4.8% vs 2.8% in June), transportation services (3.5% vs 3.4%) and new vehicles (0.4% vs 0.2%) while inflation steadied for food (2.9% vs 2.9%). On the other hand, inflation slowed slightly for shelter (3.7% vs 3.8%) and energy cost declined more (-1.6% vs -0.8%). Prices for gasoline (-9.5% vs -8.3%) and fuel oil (-2.9% vs -4.7%) continued to decrease while the rise for natural gas prices remained elevated (13.8% vs 14.2%).On a monthly basis, the CPI rose 0.2%, just below June's 0.3% gain which was the strongest since January and matching expectations. Meanwhile, core inflation, which excludes food and energy, accelerated to a five-month high of 3.1%, compared to 2.9% in June and above forecasts of 3%. The monthly core CPI went up 0.3% as expected, its sharpest rise in six months, after 0.2% previously.


The value of new owner-occupier loan commitments for dwellings in Australia rose 2.4% quarter-on-quarter to AUD 54.7 billion in Q2 2025, rebounding from a downwardly revised 1.8% decline in Q1. The recovery was driven by gains in both first-home buyer loans (5.7% vs -3.0% in Q1) and non-first-home buyer loans (4.4% vs 1.4%). On an annual basis, owner-occupier lending surged 7.4%. Meanwhile, investment lending for homes increased 1.4% to AUD 32.9 billion, improving from an upwardly revised flat reading in the previous quarter. Year-on-year, investment loan values rose 6.9%.

Australia's seasonally adjusted Wage Price Index rose by 3.4% yoy in Q2 2025, matching the previous quarter's pace and exceeding expectations of a 3.3% increase. An acceleration in both the public and private sectors drove the stronger-than-expected growth. Public sector wages surged by 4.7%, up from 3.6% in Q1, while private sector wages rose by 3.4%, compared to 3.3% previously. This marks a rebound for the private sector, which had recorded its weakest growth since Q2 2022 in the prior two quarters. In original terms, the electricity, gas, water, and waste services industry recorded the highest annual wage increase at 5.0%, followed by information media & telecommunications and healthcare & social assistance, which both rose by 3.9%. The main contributors to the quarterly wage growth were roles in professional, scientific, and technical services. On a quarterly basis, wage prices increased by 0.8%, down from a 0.9% gain in the previous quarter and in line with market forecasts.


