
MARKET COMMENTARY


The Aussie market starts the new month on a negative note as global funds took profit in big caps. The small and micro cap were up on the day. US creates more macro mess with (1) tariffs are under legal threat and likely to change into new tariffs (2) US Fed preferred inflation rose for the third month in a row to hit 5 month high (3) US removed minimum \$800 no duty imports used by retail and that hits consumers (4) White House is planning to take over Chicago and (5) US Fed under attack from White House to cut rates despite rising inflation. Naturally when the government functions like a clown show, spot gold hits all-time high. Inflation is going higher, and growth is going lower. China is not raining stimulus or pumping property. RBA has no plans but pump property despite most can't afford it already. If you don't have exposure to inflation sector, maybe it's time to change. Do you have enough Gold? It may be different this time!

CNBC – Tariffs > As if the ever-changing trade mandates from U.S. President Donald Trump weren't hard enough for companies, here comes a new complication: the federal appeals court. On Friday, the U.S. Court of Appeals for the Federal Circuit ruled that Trump's imposition of "reciprocal" tariffs on countries, as well as those on China, Canada and Mexico ostensibly in relation to fentanyl trafficking, was an overreach of his authority. That said, those tariffs will be allowed to persist until Oct. 14 so that the Trump administration has time to appeal to the U.S. Supreme Court. At first blush, this development might seem to benefit stocks, which have already had a rip-roaring August. For the month, the S&P 500 added nearly 2%, the Dow Jones Industrial Average advanced over 3% and the Nasdaq Composite rose 1.6%. However, tariffs flickering on and off might be more anxiety-inducing than the certainty of planning strategies around tackling those duties. And that means potential volatility in markets.

CNBC – Retail into US > The de minimis exemption, an obscure trade law provision that has simultaneously fueled and eroded businesses across the globe, officially came to an end on Friday following an executive order by President Donald Trump. For nearly a decade, shipments valued under \$800 were allowed to enter the country virtually duty-free and with less oversight. Now, those shipments from the likes of Tapestry, Lululemon and just about any other retailer with an online presence will be tariffed and processed in the same way that larger packages are handled. In May, Trump ended the exemption for goods coming from China and Hong Kong, and on July 30 he expanded the rollback to all countries, calling it a "catastrophic loophole" that's been used to evade tariffs and get "unsafe or below-market" products into the U.S. The de minimis exemption had previously been slated to end in July 2027 as part of sweeping legislation passed by Congress, but Trump's executive order eliminated the provision much sooner, giving businesses, customs officials and postal services less time to prepare.

Historically, 75% of retail investors have experienced losses during positive market periods. Investors are now facing market cycles that are unprecedented in their lifetime, making risk management a crucial aspect of investing. Going forward, the trend towards active investing is reemerging as investors seek quality, relative value, profitability, and dividends. The HCOB Eurozone Manufacturing PMI rose to 50.7 in August 2025, up from a flash estimate of 50.5 and July's 49.8, signaling the first monthly improvement in factory conditions since June 2022. Growth was led by Greece, followed closely by Spain, while modest gains were recorded in the Netherlands and Ireland. France and Italy returned to slight expansions, and contractions in Germany and Austria eased. Output growth reached its strongest since March 2022, and new orders rose for the first time in nearly three and a half years. Despite these signs of recovery, job cuts persisted and backlogs of work fell for the 39th straight month. On the price front, input costs rose for the first time since March, though only marginally, while output prices continued to decline. Business confidence was little changed from July.

Indonesia's annual inflation eased slightly to 2.31% in August 2025, down from 2.37% in July, which had marked the highest rate since June 2024. The latest reading remained within the central bank's target range of 1.5% to 3.5%. Inflation slowed in several categories, including education (1.43% vs 1.95% in July), clothing (0.81% vs 1.94%), accommodation and restaurants (1.85% vs 1.86%), and furnishing (0.42% vs 0.52%). Meanwhile, inflation accelerated for food (3.99% vs 3.75%) and health (1.91% vs 1.84%), while remaining steady for housing (at 1.65%). Prices also fell for transport (-0.29% vs 0.12%) and communication (-0.33% vs -0.31%). Core inflation, which excludes administered and volatile food prices, declined to an eleven-month low of 2.17% in August, down from 2.32% in July. On a monthly basis, the Consumer Price Index (CPI) edged down by 0.08%, marking the first monthly decline in three months and reversing a 0.3% increase in the previous month.


China's official NBS Manufacturing PMI inched up to 49.4 in August 2025 from July's three-month low of 49.3, marking the fifth straight month of drop in factory activity and falling short of market estimates of 49.5. Output grew for the fourth consecutive month and at the fastest pace since March (50.8 vs. 50.5 in July), lifted by the extension of the tariff truce between Washington and Beijing for another 90 days. Also, buying levels rose the most in five months. Still, overall demand remained sluggish, with new orders (49.5 vs. 49.4) showing little improvement despite fresh consumer subsidies and export sales (47.2 vs. 47.1) continuing to fall amid weak overseas demand and lingering trade barriers. Employment stayed soft (47.9 vs. 48.0), due to job uncertainty. Delivery times shortened to a six-month high (50.5 vs. 50.3). On prices, input costs hit their highest since October 2024, while a decline in selling prices eased. Finally, confidence notched a six-month peak (50.5 vs. 50.3).

ANZ-Indeed Australian Job Ads inched up 0.1% month-on-month in August 2025, reversing a downwardly revised 0.6% fall in the previous month and underscoring a resilient labour market amid lower interest rates. "The ongoing resilience in Job Ads supports our view that the unemployment rate is likely to track broadly sideways," said ANZ economist Madeline Dunk, who expects just one more 25bps cut from the RBA in November. The central bank lowered rates to 3.6% in August, its third cut this year, as inflation eased and joblessness ticked higher. On a yearly basis, job ads rose 1.9%, and remained 15.1% above pre-pandemic levels. Meanwhile, Indeed's Callam Pickering noted a sharp rebound in education job postings in August, previously a drag on hiring, alongside strong gains in retail and food services. He added that retail demand will accelerate further into the holiday season, particularly with Black Friday sales approaching.

The seasonally adjusted number of total dwellings approved in Australia dropped by 8.2% month-overmonth to 15,769 units in July 2025, more than market expectations of a 4.8% fall and reversing an upwardly revised 12.2% increase in June, preliminary data showed. The decline was largely due to a sharp fall in approvals for private sector dwellings excluding houses (-22.3% vs 33.5% in June). In contrast, approvals for private sector houses rose by 1.1%, after a 1.9% drop in the previous month. By state, approvals fell in New South Wales (-24.6%) and South Australia (-1.3%), while increased in Tasmania (12.2%), Western Australia (11.8%), Queensland (5.9%), and Victoria (0.7%). On a yearly basis, total dwellings approved rose by 6.6%, slowing from an upwardly revised 28.0% growth in the previous month.


