
MARKET COMMENTARY


The Aussie market started negatively and finished positively on the back of global asset allocation moves chasing equities at extreme multiples. Global passive money was pushing our market higher with the big caps moving on the global flow at market level. US government shutdown is fake as usual. White House was going to fire substantial amount of government workers, newly election democrats were going to tip the vote to release Epstein files, and the economy is rolling over. The shutdown is a good patsy to blame and hide/delay everything. All the major global corporations are playing the political game to avoid being targeted by the White House and global passive funds are no different. Throughout history, mega corporates align themselves where they get the best self-interest outcome. Unfortunately the middle to low income are going to pay the cost and they can't afford it. We are unlikely to get NonFarm Payrolls tonight as it is likely to be very ugly. It may be different this time!

CNBC – Ukraine War > Russian President Vladimir Putin warned the potential supply of long-range missiles to Ukraine would mark a "completely new stage of escalation" between Washington and Moscow. Speaking on Thursday at a forum in Russia's Black Sea resort of Sochi, Putin conceded that the supply of "powerful" U.S. Tomahawk cruise missiles to Kyiv posed a threat to Russia but would not change the situation on the battlefield. "Can Tomahawks harm us? They can. But we will shoot them down and improve our air defense system," Putin said, according to an NBC translation. "Using Tomahawks without the direct participation of American military personnel is impossible. This would mark a qualitatively new, completely new stage of escalation between Russia and the U.S.," he added. His comments come shortly after it was reported the U.S. would provide Ukraine with intelligence on long-range energy infrastructure targets deep inside Russia, a move that would represent a significant shift in White House support for Kyiv.

CNBC – US and Taiwan > Taiwan will not accept Washington's proposal to locally manufacture half the chips it currently supplies to the U.S., the island's top trade negotiator said. Speaking to reporters, Cheng Li-chiun, also the country's vice premier, said on Wednesday that the proposal for a "50-50" split in semiconductor production was not even discussed, as she returned from trade talks in the U.S., according to Taiwan's Central News Agency. Cheng said the talks were focused on lowering tariff rates, securing exemptions from tariff stacking — additional duties — and reducing levies on Taiwanese exports. Taiwan currently faces a "reciprocal" tariff rate of 20%. Washington has held discussions with Taipei about the "50-50" split in semiconductor production, which would cut American reliance on Taiwan, Commerce Secretary Howard Lutnick said last weekend in an interview to NewsNation, adding that currently 95% of the U.S. demand was met via chips produced within Taiwan.

Services PMI In the Euro Area increased to 51.30 points in September from 50.50 points in August of 2025. Services PMI in the Euro Area averaged 51.48 points from 2007 until 2025, reaching an all time high of 59.80 points in July of 2021 and a record low of 12 points in April of 2020.

Turkey's annual inflation accelerated to 33.29% in September 2025, ending a 15-month streak of slowing consumer price growth, up from 32.95% in August and well above market expectations of 32.5%. The increase was driven by faster price growth in transportation (25.30% vs 24.86% in August), clothing and footwear (9.8% vs 9.49%), communication (23.20% vs 20.61%), and education (66.10% vs 60.91%). In contrast, price growth moderated in housing and utilities (51.36% vs 53.27%), food and non-alcoholic beverages (33.06% vs 33.28%), alcoholic beverages and tobacco (24.49% vs 29.71%), household furnishings and maintenance (29.32% vs 29.74%), recreation and culture (24.85% vs 26.16%), health services (35.21% vs 36.59%), and miscellaneous goods and services (31.06% vs 33.03%). Core inflation eased to 32.54% from 33.0% in August. On a monthly basis, consumer prices rose 3.23% in September, following a 2.04% increase in August and beating the expected 2.6% gain.


Retail sales in Singapore climbed by 5.2% year-on-year in August 2025, accelerating from a downwardly revised 4.6% increase in the previous month. This marked the strongest growth in retail activity since February of last year, mainly driven by higher sales of furniture and household equipment (8.6% vs 2% in July), recreational goods (9.9% vs 6.8%), and others (1.6% vs -0.3%). Additionally, trade declined to a lesser extent for wearing apparel and footwear (-1.4% vs -4.2%) and petrol service stations (-5% vs -5.6%). On the other hand, activity decreased in department stores (-6.5% vs 4.1%) and mini-marts and convenience stores (-1.7% vs 0%), while sales growth softened for computer and telecommunications equipment (7.4% vs 10.9%). On a monthly basis, retail sales rose by 0.5% in August, slowing from a downwardly revised 3.9% advance in the preceding period.

The S&P Global Japan Services PMI rose to 53.3 in September 2025, above the flash estimate of 53.0 and August's 53.1, signaling the sixth straight month of expansion in the service sector. New orders increased solidly, unchanged from August, supported by business development efforts and new client acquisitions, though foreign demand continued to decline. Employment edged up for the first time in three months, while capacity pressures persisted as outstanding business grew further, albeit at a slower pace than August's 26-month high. On costs, input price inflation eased but remained sharp and above the long-term average, driven by higher labor, raw material, and fuel costs. In turn, service providers raised output charges at a solid pace. Business sentiment strengthened to its highest since January, reflecting expectations of company expansions, new product launches, and stronger customer spending.

The S&P Global Australia Services PMI Business Activity Index slipped to 52.4 in September from 55.8 in August, signaling continued growth in services activity and extending the expansion streak to 20 months, though at the weakest pace since June. Strong client demand and successful business development supported growth in both domestic and export markets, with inquiries from Europe and the Asia-Pacific driving a second consecutive monthly rise in overseas orders. Staffing levels increased in response to higher new business inflows, aided by improved candidate availability, resulting in the fastest job creation since April. Backlogs edged up slightly for the first time in five months, largely due to supply shortages, while input costs continued to rise, prompting firms to lift output charges even as inflation eased to three-month lows.




