MARKET COMMENTARY

The Aussie market was negative after the bashing yesterday. US market keeps rolling over and that kept sentiment weak but local market was expected to bounce after the worst day since US "Liberation Day" disaster. US continues to backflip on every policy and grift on every trade. The deals don't even make sense anymore. Supposedly US has \$22trill pledged for investment when their GDP is less than \$30trill. Saudis pledged nearly their whole GDP. No one is going to invest their whole GDP in another country. But we are in a cycle where it can be announced and taken seriously. Locally wages came in solidly and wage growth remains dramatically higher than the decade pre pandemic. There is no rate cut from RBA coming and we may have seen the last one as inflation starts to rise around the world. Growth stocks are getting hammered and defense stocks are on the chopping block. This is not a market where growth stocks can have management change or downgrade expectations without major pain. It may be different this time!

CNBC – China and Japan > Japan's fragile economy, already hurt by U.S. tariffs and declining investments in property, faces another hit due to the diplomatic spat between Tokyo and Beijing. Miffed over Japanese Prime Minister Sanae Takaichi's comments related to Taiwan, China on Friday advised its citizens against travelling to the country. Japanese tourism-exposed stocks fell in the aftermath of that warning, while experts caution the impact could be more severe over a longer duration. Mainland Chinese tourists have been the largest group of foreign visitors to Japan so far in 2025 at about 5.7 million, or nearly 23% of all visitors, according to Japan's National Tourism Organisation.

CNBC – US and Saudi Arabia > President Donald Trump and Saudi Arabia's Crown Prince Mohammed bin Salman, the de facto ruler of his nation, on Tuesday brushed off questions about bin Salman's involvement in the 2018 killing of the Saudi journalist Jamal Khashoggi in the Saudi consulate in Istanbul. "Things happen," Trump said when asked about Khashoggi's killing by Mary Bruce of ABC News, as he sat next to bin Salman in the Oval Office. Khashoggi, who was a critic of the regime, was also a U.S. resident. Trump called the ABC News reporter "fake news" after she asked about Khashoggi, about claims by families of 9/11 victims that Saudi Arabia bankrolled the Sept. 11, 2001, terror attacks, and about the propriety of Trump's business investing in Saudi Arabia. "You're mentioning somebody that was extremely controversial," Trump said of Khashoggi. "A lot of people didn't like that gentleman that you're talking about, whether you like him or didn't like him, things happen," Trump said. Referring to bin Salman, Trump said, "But he knew nothing about it, and we can leave it at that." "You don't have to embarrass our guests by asking a question," Trump said.

Japan's core machinery orders, which exclude volatile sectors such as ships and electric power, jumped 4.2% month-over-month to ¥927.8 billion in September 2025, reversing from a 0.9% fall in August and exceeding market expectations for a 2.5% gain. The increase was led by the manufacturing sector, which jumped 23.3% to ¥515.2 billion, while non-manufacturing orders fell 8.7% to ¥428.3 billion. By industry, the largest advances came from chemical and chemical products (388.9%), pulp, paper and paper products (84.5%), other transport equipment (40.7%), mining and quarrying of stone and gravel (40.4%), and general-purpose and production machinery (29.7%). On an annual basis, private-sector orders grew 11.6% in September, accelerating from a 1.6% gain in August and beating forecasts of 5.4%. Core machinery orders are seen as a key yet volatile leading indicator of capital expenditure over the coming six to nine months.

The UK's annual inflation rate eased to 3.6% in October 2025, the lowest level in four months, down from 3.8% recorded in each of the previous three months. The figure came in line with expectations from both the Bank of England and market analysts. Prices slowed for housing and utilities (5.2% vs 7.3%), namely gas (2.1% vs 13%) and electricity (2.7% vs 8%) due to a change in the Office of Gas and Electricity Markets energy price cap in October. Smaller price increases were also seen for restaurants and hotels (3.8% vs 3.9%), services (4.5% vs 4.7%) and clothing and footwear (0.3% vs 0.5%). On the other hand, inflation for transportation was unchanged at 3.8% while it accelerated for food and non-alcoholic beverages (4.9% vs 4.5%) and recreation and culture (2.9% vs 2.7%). Compared to the previous month, the CPI rose 0.4%, following a flat reading in September and matching forecasts. Meanwhile, annual core inflation dropped to a six-month low of 3.4%.


Bank Indonesia (BI) maintained its benchmark interest rate unchanged at 4.75% during its November 2025 policy meeting, in line with expectations. The rate remains at its lowest level since October 2022, following cumulative cuts of 150 bps since September last year. The decision reflects the central bank's view that inflation for 2025-2026 will stay within the target range of $2.5\% \pm 1\%$, supported by a stable rupiah and continued measures to sustain economic growth. Recent data showed that GDP grew 5.04% year-on-year in Q3, easing from the two-year high recorded in Q2, while annual inflation accelerated to 2.86% in October, the highest since April 2024, though still within BI's target range. BI also left the overnight deposit facility rate and the lending facility rate unchanged at 3.75% and 5.50%, respectively.

The Westpac–Melbourne Institute Leading Economic Index for Australia edged up 0.1% month-over-month in October 2025 after a flat reading in the previous month. The six-month annualized growth rate also improved, rising to 0.35% from 0.1%. After hovering around zero for much of the past six months, the index has begun to show modest momentum heading into year-end, with the October update indicating slightly above-trend growth in early 2026. Although the signal is mild, it aligns with expectations that activity will continue to strengthen through the rest of 2025 and into next year. Westpac economist Ryan Wells forecasts GDP growth to pick up from 1.8% currently to 2.4% in 2026. On interest rates, Westpac expects the RBA to keep the cash rate on hold until mid-2026, by which time easing inflation should be more evident. This would allow for potential rate cuts in May and August, returning policy to broadly neutral settings.

Australia's seasonally adjusted Wage Price Index rose by 3.4% year-on-year in Q3 2025, unchanged from the previous quarter and in line with market expectations. Public sector wages increased by 3.8%, slightly above the 3.7% rise in Q2, while private sector wages grew by 3.2%, easing from 3.4% previously. In original terms, the electricity, gas, water & waste services industry and public administration recorded the strongest annual wage gains at 4.3% each. They were followed by healthcare and social assistance (3.8%), mining (3.6%), education and training (3.6%), construction (3.4%), rental, hiring, and real estate services (3.3%), and professional, scientific & technical services (3.3%). Healthcare and social assistance roles were the main contributors to quarterly wage growth. On a quarterly basis, overall wage prices rose by 0.8%, matching the previous quarter and aligning with market forecasts.




