
MARKET COMMENTARY


The Aussie market started positively and faded through the day to deliver a slightly positive close. After the solid negative start to the month on Monday, the expected bounce did not last. US policy volatility rose again as White House targeted Venezuela, Honduras and everything that could be a distraction. Trumpster Hassett is seen as the insider appointment for US Fed chief after Powell and that will be the death of US Fed independence. We may be facing a worse connection than the disaster that is the Japanese government and BOJ. While the White House works out who to blame for their mistakes, the economy keeps sliding down while debt spending keeps running at peak speed. Ukraine and Middle East wars are up and running. China friction with Japan over Taiwan is fueling up again. Chinese techs are delivering more AI offering to challenge Google after their latest AI outperformed the OpenAI/Nvidia play. There is no certainty about who will win. The only things that are certain are policy failures and denial of reality. It may be different this time!

CNBC – US Fed > President Donald Trump knows who he's going to select as the next Federal Reserve chair but isn't saying yet. Prediction markets have their minds made up, but the front-runner also is playing it coy. While that part of the mystery appears ready to clear up in the coming weeks, what's far less certain is the type of environment the new central bank leader will face at a potential crossroads for the U.S. economy. National Economic Council Director Kevin Hassett has been dubbed the clear favorite, buoyed by a Bloomberg News report last week that handicapped the five-person race to succeed current Chair Jerome Powell, whose term runs out in May. Asked Sunday about the situation, Trump told reporters aboard Air Force One, "I know who I am going to pick, yeah. We'll be announcing it." Beyond that, he smirked when asked about Hassett, adding "I'm not telling you, we'll be announcing it." The candidate himself made the rounds on the weekend talk circuit, also dodging questions about his prospects. Hassett is part of a field that also includes current Governors Christopher Waller and Michelle Bowman, former Governor Kevin Warsh and BlackRock fixed income chief Rick Rieder.

CNBC – South Korea > South Korea's consumer prices rose 2.4% in November from a year earlier, driven by higher food and services costs, bolstering the case for the Bank of Korea to maintain interest rates at the current level for longer. The consumer price index was roughly in line with median forecasts for a 2.35% figure, but stayed above the BOK's inflation target level of 2% for a third straight month. An index on prices of agricultural and fishery products increased 5.6% from a year earlier, mainly because prices of fresh produce, including rice and mandarins, soared 18.6% and 26.5%, respectively. The BOK kept interest rates unchanged for a fourth straight meeting at 2.50% last week as a tumbling won currency reduced the scope for further easing and signaled the bank could be nearing the end of its current rate cut cycle.

The UK Nationwide House Price Index rose 1.8% year-on-year in November 2025, above the expected 1.4% but slowing from October's 2.4% gain, marking the softest annual growth since June 2024. On a monthly basis, prices increased 0.3%, compared to expectations of no growth and up from 0.2% in the prior period. Nationwide Chief Economist Robert Gardner noted resilience despite subdued consumer confidence, early signs of labour market weakness, and mortgage rates more than double pre-Covid levels, with prices near all-time highs. He added that steady mortgage approvals and ongoing demand, particularly from first-time buyers, support market stability. Gardner expects modest affordability improvements if income growth outpaces house prices, aided by potential Bank Rate cuts and strong household balance sheets. Housing activity is likely to remain steady, with limited impact from upcoming property tax changes and continued upward pressure on rental growth due to constrained supply.


South Korea's annual inflation rate held at 2.4% in November 2025, unchanged from the previous month and remaining at its highest level since July 2024. The latest figure also stayed above the central bank's 2% target for a third straight month. Price continued to rise for all components: food & non-alcoholic beverages (4.7% vs 3.5% in October), tobacco (0.1% vs 0.4%), clothing (2.3% vs 2.1%), furnishings, household equipment & routine maintenance (1.2% vs 1.2%), housing (2.8% vs 2.2%), household goods (1.1% vs 2.2%), health (1.1% vs 0.9%), transport (3.2% vs 3.4%), communication (0.4% vs 0.4%), culture (1.4% vs 2.1%), education (1.7% vs 1.8%), restaurants & hotels (2.9% vs 3.2%), and miscellaneous goods & services (4.2% vs 4.3%). On a monthly basis, consumer prices declined 0.2%, swinging from a 0.3% rise in October and marking the first drop since August.

Australia's current account deficit widened to AUD 16.6 billion in the third quarter of 2025, up from an upwardly revised AUD 16.2 billion in the second quarter and exceeding market expectations of a AUD 13.3 billion shortfall. This marked the largest current account gap since the fourth quarter of 2024, as the goods and services surplus declined to AUD 2.5 billion in Q3 2025 from AUD 2.8 billion in the previous quarter, while the net secondary income shifted to a deficit of AUD 0.5 billion from a surplus of AUD 0.06 billion. Meanwhile, the net primary income deficit narrowed to AUD 18.7 billion in Q3 from AUD 19.0 billion in Q2, driven by a AUD 1.7 billion rise in primary income credits (inflows) and partly offset by an increase of \$1.4 billion in primary income debits (outflows). The increase in inflows was driven by higher profits from Australian direct equity investment holdings and continued strong returns on portfolio equity investments held overseas.

The seasonally adjusted number of total dwellings approved in Australia fell 6.4% month-on-month to 15,832 units in October 2025, reversing a downwardly revised 11.1% surge in September, according to preliminary estimates. The latest reading was worse than market forecasts of a 4.5% decline, with approvals for private-sector dwellings excluding houses plunging 13.1%, reversing a downwardly revised 25.0% jump in the previous month, while private-sector house approvals shrank 2.1% following a downwardly revised 3.2% rise. By state, approvals decreased in Victoria (-24.7%) and New South Wales (-20.6%), while Western Australia (28.1%), South Australia (11.2%), and Queensland (2.4%) recorded increases. On a yearly basis, total dwelling approvals declined 1.8%, after a downwardly revised 14.9% surge in the previous month.




