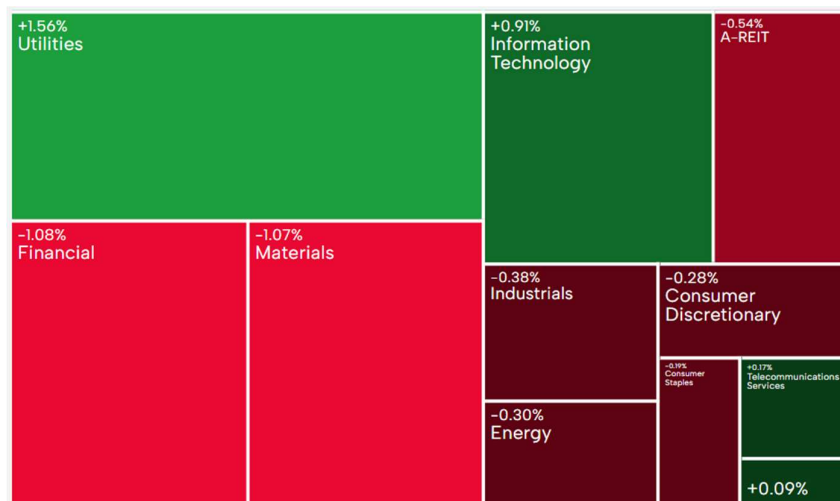
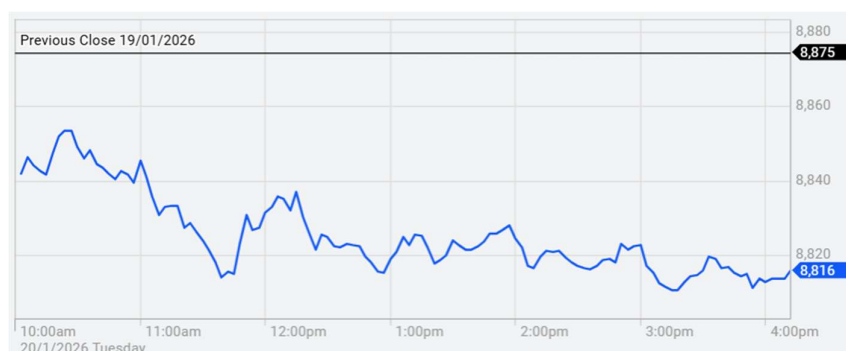
MARKET COMMENTARY

The Aussie market had the second consecutive negative day to start the new week. US market was closed tonight for MLK holiday. White House has thrown new tariffs on anyone trading with Iran and EU countries to handover Greenland. It was done on the weekend to be able to walk away before the US market opens on Tuesday. Trump has raised the tariff on EU countries to 25% from 10% but no real change expected. US has also threatened 200% tariff on French wine and champagne after French president turned down a spot on Board of Peace being organized by US to control the reconstruction of genocide land of Gaza. The standard of board members is comical as Putin is also invited. Trump has claimed that Greenland move is linked to not getting Nobel peace prize. US is fast running out of policy pathway to win mid-terms and likely to keep ramping up policy uncertainty till something breaks. Logica suggest that White House will delay announced tariffs by six months or so to cover up another TACO. It may be different this time!

CNBC – US Reality Show > U.S. President Donald Trump on Tuesday threatened to impose 200% tariffs on French wines and champagne after French President Emmanuel Macron was reported to be unwilling to join his “Board of Peace” on Gaza. When asked for a response by a reporter in Miami about Macron’s stance, Trump dismissed the French leader’s influence and said he would use trade penalties as leverage. “Well, nobody wants him because he’s going to be out of office very soon,” Trump said. “So you know, that’s all right. What I’ll do is, if they feel like [being] hostile, I’ll put a 200% tariff on his wines and champagnes, and he’ll join. But he doesn’t have to join.” The Board of Peace is a global body endorsed by the United Nations Security Council in November last year, established to oversee the Israel-Hamas ceasefire. Invites to various world leaders to be on the board have been sent, including to Russian President Vladimir Putin, UK Prime Minister Keir Starmer and Indian Prime Minister Narendra Modi.

CNBC – Japan > Japan’s 40-year government bond yield hit a record high on Tuesday amid a broad selloff in government bonds, as investors worried that proposed cuts to the food sales tax could worsen the country’s fiscal position. The long-dated yield rose more than 5 basis points to 4%, the highest level since the 40-year maturity was introduced. Yields on shorter maturities climbed sharply as well. The 10-year Japan government bond yield rose by over 6 basis points to 2.3%, the highest level since 1999, while yields on the 20-year tenor jumped by around 9 basis points to 3.35%. The selloff came a day after Prime Minister Sanae Takaichi said she plans to dissolve parliament on Friday and call a snap election on Feb. 8, setting the stage for a campaign that is expected to focus heavily on economic policy. It was a repeat of the volatility seen in October last year, when Japanese markets reacted to comments and policy signals from Takaichi that pointed toward looser fiscal policy, which later stabilized.

Real estate prices in Saudi Arabia fell by 0.7% year-on-year in Q4 2025, reversing a 1.3% gain in the previous quarter. This marked the first annual decline since Q4 2020, as residential property prices continued to decline (-2.2% vs -0.9% in Q3) amid lower prices for residential land (-2.4%), apartments (-2.5%), villas (-1.3%), and residential floors (-0.2%). In addition, a sharp slowdown was recorded in both commercial property prices (3.6% vs 6.8%) and the agricultural sector (4.3% vs 15.3%). Among administrative regions, the Hail region posted the steepest annual price decline at 8.9%, while the Eastern region recorded the highest increase at 4%. Elsewhere, the Riyadh region saw a 3% decrease. On a quarterly basis, real estate prices fell by 0.4% in Q4, easing from a 1.1% drop in the previous quarter.

The People's Bank of China (PBoC) kept key lending rates at record lows for an eighth consecutive month in January, in line with market expectations, after earlier reductions to the central bank's relending and rediscount facility rates had already taken effect. Last Thursday, the PBoC announced cuts to sector-specific interest rates of 25 bps, effective January 19, to provide an early boost to the economy. The one-year Loan Prime Rate (LPR), the benchmark for most corporate and household borrowing, remained at 3.0%, while the five-year LPR, which anchors mortgage rates, was unchanged at 3.5%. Both rates were last cut by 10 bps in May. The decision followed data released on Monday showing that GDP growth in 2025 met the official target of 5%, despite a lingering property sector crisis. Meanwhile, new yuan loans in December were significantly higher than in November and exceeded market expectations, supported by government stimulus measures aimed at boosting credit demand.

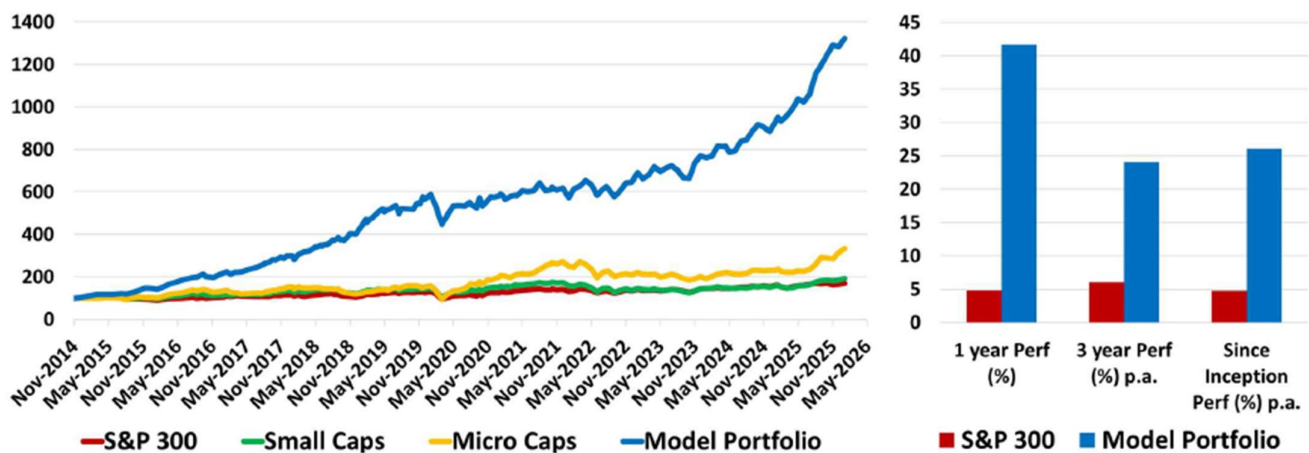
South Korea's producer prices rose 1.9% year-on-year in December 2025, matching November's pace and marking the strongest increase since July 2024, as price pressures remained broad-based across key categories. Costs increased for services (2.2% vs 2.2% in November), manufacturing (1.9% vs 1.9%) and agricultural, forestry and marine products (6.1% vs 5.5%), reflecting a sharp rebound in farm-related prices. By contrast, prices for electricity, gas and water remained in contraction at -1.4%, extending the decline from -1.2% previously. On a monthly basis, producer prices rose 0.4% in December, accelerating from a 0.3% increase in November.

Eurozone consumer price inflation eased to 1.9% in December 2025, down from 2.1% in November and slightly under the preliminary estimate of 2.0%. It marked the first time since May that inflation has come in below the European Central Bank's 2% target, reinforcing expectations that interest rates will remain on hold for an extended period. Services inflation moderated to 3.4% from 3.5%, while price growth for non-energy industrial goods softened to 0.4% from 0.5%. Energy prices fell more sharply, declining 1.9% year-on-year compared with a 0.5% drop in November. By contrast, inflation in food, alcohol, and tobacco edged higher to 2.5% from 2.4%. Core inflation, excluding energy, food, alcohol, and tobacco, slipped to 2.3%, its lowest level in four months. Among the euro area's largest economies, harmonized inflation cooled in Germany (2.0% vs. 2.6%), France (0.7% vs. 0.8%), and Spain (3.0% vs. 3.2%). Italy was the exception, with HICP inflation ticking up modestly to 1.2% from 1.1%.

The headline inflation rate in Canada rose to 2.4% in December of 2025 from 2.2% in the previous month, the highest in three months, and firmly above market expectations that the rate would remain unchanged. The result contrasted slightly with the Bank of Canada's expectations that CPI inflation would remain around the 2% threshold in the near-term. The acceleration reflected base effects from the temporary GST and HST break introduced in December 2024, triggering higher inflation rates for food purchased from restaurants (8.5% vs 3.3% in November), alcoholic beverages from stores (5.6% vs 3%), and toys, games, and hobby supplies (7.5% vs -0.5%). Meanwhile, inflation eased for shelter (2.1% vs 2.3%) and prices fell for transportation (-0.5% vs 0.7%). Consequently, the median core inflation rate, which is closely monitored by the BoC as a gauge for underlying price growth, slowed to a one-year low of 2.5%.

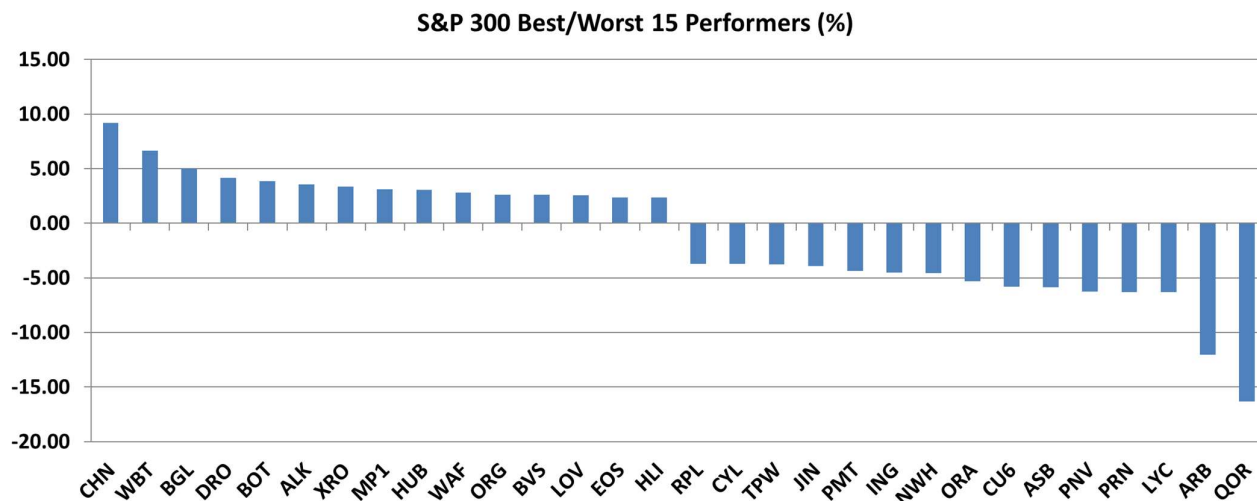
