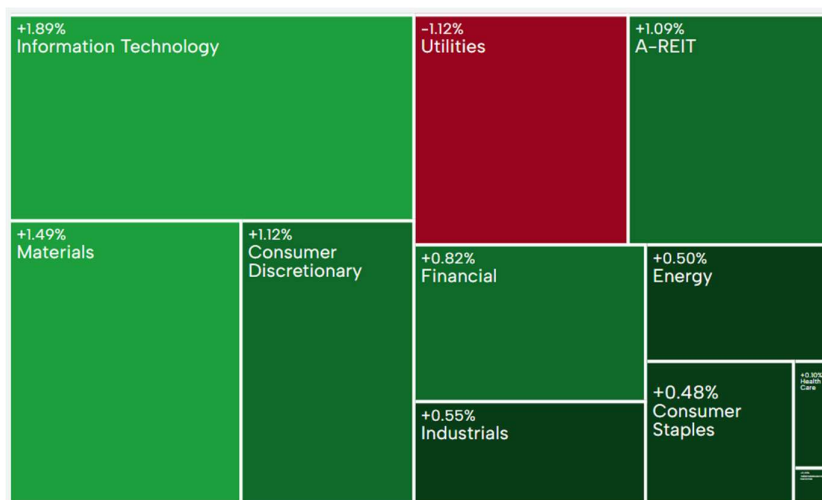
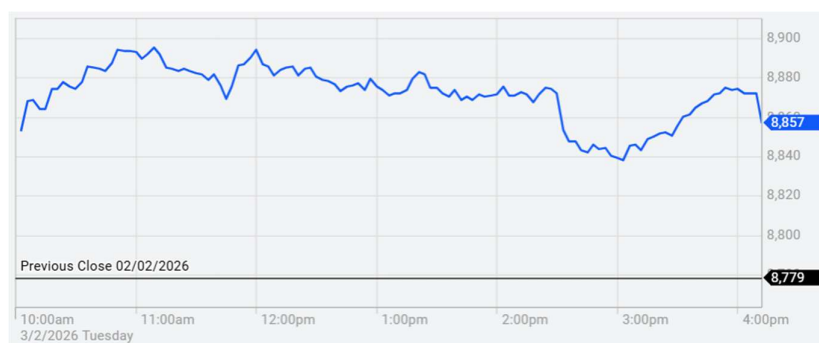
## MARKET COMMENTARY

The Aussie market bounced back from yesterday's belting after US announced a trade deal with India. You can always be sure that White House will deliver a positive catalyst for global passive funds to pump market after a few negative days. Since everything else is sliding, White House has attached itself to the equity market. Hence, they want interest rate cuts to keep multi-decade high multiples. Such that, pundits saying that the new Fed chief will be hawkish does not stack up. The bashing of precious metals is reversing, and it had nothing to do with Fed chief announcement but everything to do with banks unable to match up paper commodities with physical. South Korea is a classic example of global flow becoming extreme. It fell over 5% and triggered a trading halt and it bounced over 6% today and nothing happened. Locally RBA hiked as expected but was still impressed that they did. Usually they will drag their feet for months and then do it late. They are fast to cut and late to hike but that's what you get when your model is property pumping. Banks went up today despite RBA move hurting them because of global flow. It may be different this time!

CNBC – US and India > The U.S. and India have reached a trade deal and will immediately move to lower tariffs on each other's goods, President Donald Trump announced. Prime Minister Narendra Modi also agreed to buy American products "at a much higher level" as part of the agreement, Trump said in a Truth Social post Monday following a call with the Indian leader. Modi additionally committed to "stop buying Russian Oil, and to buy much more from the United States and, potentially, Venezuela," Trump said in the post. Trump's announcement asserts the agreements struck on the call will take effect without delay, but the text of the deal has yet to materialize and it is unclear if anything has been signed. The White House and the Office of the U.S. Trade Representative did not immediately respond to CNBC's requests for additional information.

CNBC – Australia > Australia's central bank raised its policy rate by 25 basis points to 3.85% on Tuesday, marking the Reserve Bank of Australia's first rate hike since November 2023 as inflation continues to climb. The Reserve Bank of Australia's move matched expectations from economists polled by Reuters and followed data showing inflation at its highest level in six quarters. The board voted unanimously to lift the cash rate, marking a reversal in direction after delivering three rate cuts in 2025. "Private demand is growing more quickly than expected, capacity pressures are greater than previously assessed and labour market conditions are a little tight," according to the central bank's statement, noting that inflationary pressure picked up "materially" in the second half of last year. "Inflation is now expected to stay above the target band well into next year before gradually coming back down," said Sunny Nguyen, head of Australia economics at Moody's Analytics.

The Australian share market was supported by strength in mining stocks as gold rebounded sharply from its largest slump in more than a decade. Gold prices climbed 3.2 per cent to \$US4815 an ounce by the close, driving renewed interest in the sector. Newmont rose 5.6 per cent to \$164.75, while Evolution Mining gained 4.2 per cent to \$14.46 and Genesis Minerals advanced 1.9 per cent to \$7.10, helping underpin broader market performance.

Bank stocks also traded higher after Morgan Stanley suggested a higher cash rate environment would be supportive of net interest margins. Commonwealth Bank rose 1.1 per cent to \$153.08 despite flagging a \$68 million pre-tax provision. Westpac added 1 per cent to \$39.32, while National Australia Bank and ANZ both edged less than 1 per cent higher to \$43.04 and \$36.78 respectively.

The typically rate-sensitive technology sector recorded the strongest gains of the session. WiseTech Global climbed 1.7 per cent to \$57.38, NextDC rose 1.9 per cent to \$13.26 and Xero advanced 2.6 per cent to \$96.10 after announcing its Melio product was expected to reach profitability earlier than forecast.

In healthcare, Neuren Pharmaceuticals slumped 10 per cent to \$14.63 after its commercial partner Acadia Pharmaceuticals received a negative trend vote from European regulators on its application to market a treatment for Rett syndrome, raising concerns about future approval prospects.

Qantas shares rose 0.3 per cent to \$10.20 after the airline confirmed it had reached an agreement with Japan Airlines to transition Jetstar Japan to a new Japanese capital-led ownership structure. The move paves the way for Qantas to exit its minority stake in the carrier.

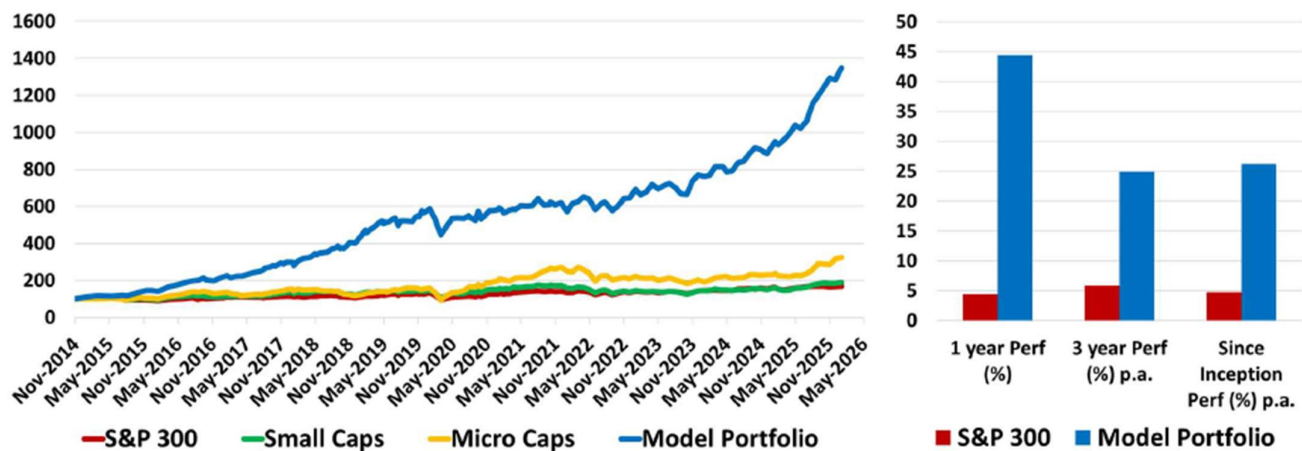
Mining services group NRW Holdings jumped 4.8 per cent to \$5.42 after securing three new civil contracts valued at a combined \$270 million. The wins strengthen its project pipeline across Western Australia and the Pilbara region, supporting earnings visibility.

Telix Pharmaceuticals fell 2.6 per cent to \$10.21 following the resignation of chairwoman Tiffany Olson after just eight months in the role, adding uncertainty around board stability.

Credit Corp suffered the sharpest decline on the market, plunging 16.7 per cent to \$11.89 after first-half results failed to meet investor expectations. Broker Morgans described the outcome as a mixed result, highlighting lowered US purchasing guidance as a key negative for sentiment.

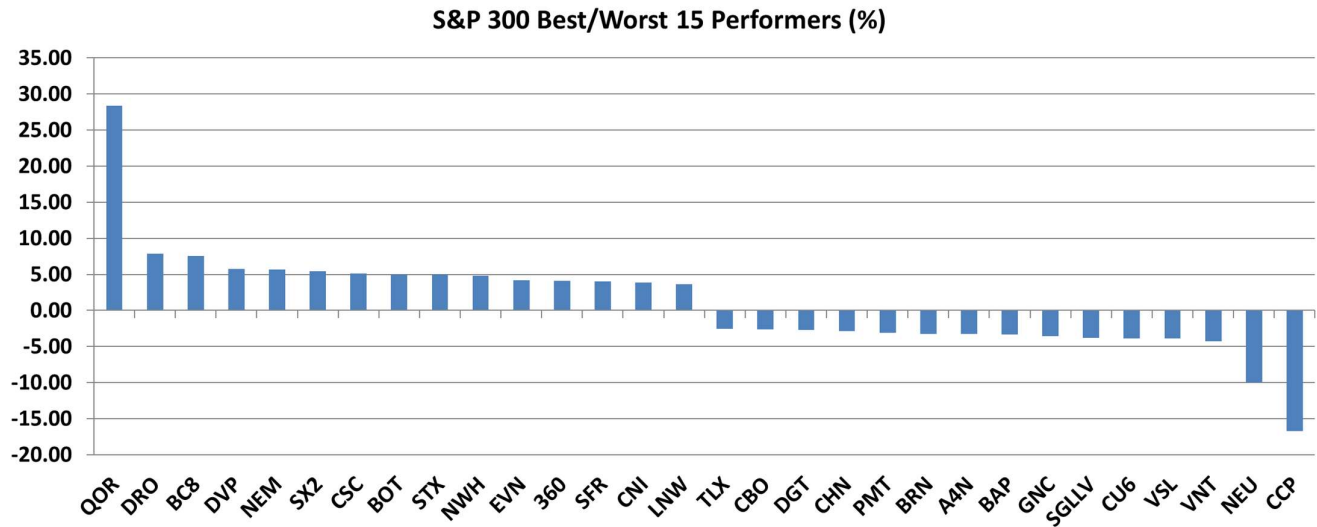
